Received sealed bids will be publicly opened and read aloud at Helms Engineering office at the above-mentioned time.

Bids are invited upon the items and approximate quantities of work as follows:

Base Bid

1. Approximately 45,000 SqFt Granular Base Course Salvage and Stockpile
2. Approximately 45,000 SqFt Granular Base Course Grading and Compaction to Achieve 3% Crown Street
3. Approximately 990.0 Tons of Asphalt Concrete Composite (Class E, Type 1)
4. Other miscellaneous construction related items.

Alt Bid Item #1

1. Approximately 990.0 Tons of Asphalt Concrete Composite (Class G, Type 1)

The award of the bid will be to the lowest responsible bidder. The approximate quantities mentioned above are subject to increase or decrease. It will be agreed by bidders that all quantities of work will be performed in accordance with the provisions of the plans and specifications and at the unit price bid. Bidders agree to furnish all labor, material, and equipment necessary to complete all the work as shown in the plans and specifications.

Additionally, upon request, in accordance with South Dakota Codified Law 5-18B-1, one copy of Plans and Specifications shall be furnished, without charge, to each Contractor resident in South Dakota who intends, in good faith, to bid upon the project.

Each bid must be accompanied by a certified check or bank draft payable to the order of the Schumaker Development, LLC, or negotiable U.S. Government Bonds (at par value) in an amount equal to five percent (5%) of the total bid. A bid bond in an amount equal to ten percent (10%) of the total bid will be accepted in lieu of a certified check or bank draft. Surety for bid bond must be authorized to do business in the State of South Dakota.

Bids may be held by Schumaker Development, LLC for a period of not more than thirty (30) days from the date of opening of bids for the purpose of reviewing the bids, investigating the qualifications of the bidders and completing financial arrangements prior to awarding the Work.
