- A. The plans and specifications are the sole property of the State;
- B. Any copies of the plans and specifications obtained directly from the State will be returned to the State immediately after the State provides notice that Bidder will not be awarded a contract, or 30 days after the bid opening for the project, whichever occurs first;
- C. Any copies of the plans and specifications made by the Bidder will be destroyed immediately after the State provides notice that Bidder will not be awarded a contract, or 30 days after the bid opening for the project, whichever occurs first;
- D. If Bidder does not submit a bid, Bidder will fulfill the requirements of B and C above on or before the date of the bid opening;
- E. The plans and specifications are to be used only with respect to this project and are not to be used for any other project or purposes other than preparing a bid for this project;
- F. The plans and specifications shall not be disseminated to any person or entity for purposes other than obtaining pricing information without the express written approval of the state;
- G. All information obtained in the plans and specifications is confidential, and;
- H. Should the Bidder disseminate the plans and specifications to an individual or entity for purposes of obtaining pricing information, the Bidder shall require that individual or entity to adhere to the terms set forth herein. The Bidder, however, assumes no liability for the misuse of the plans and specifications by such third party's failure to comply with the provisions contained herein.

Should Bidder be awarded a contract for construction of the project, Bidder does not need to return or destroy plans and specifications until after completion of the project.

Each bid in excess of \$50,000 must be accompanied by a certified check, cashier's check or draft in the amount of 5% of the base bid and all add alternates and drawn on a State or National Bank or a 10% bid bond issued by a surety authorized to do business in the State of South Dakota and made payable to the Department of the Military of the State of South Dakota.
