Sealed Bids for the construction of the **Doland Splash Park** will be received by **the City of Doland**, at the office of the **Finance Officer, City Hall, 106 2nd St, PO Box 126, Doland, South Dakota 57436**, until **2 p.m.** local time on **June 10, 2020**, at which time the Bids received will be **publicly** opened and read.

The Project consists of constructing **the following but not limited to;**

699 Square Feet Concrete Splash Park with the necessary splash features, piping, pumps, recirculation system and appurtenances along with 275 Square Feet Pump house/Restroom Building.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website as portable document format (PDF) files. The 11"x17" paper drawings and Bidding Documents may be obtained from the Issuing Office upon payment to Helms and Associates in the amount of \$100.00 for shipping and handling. Cost of Bidding Documents and shipping is non-refundable. **Additionally, upon request, in accordance with South Dakota Codified Law 5-18B-1, one copy of Plans and Specifications shall be furnished, without charge, to each Contractor resident in South Dakota who intends, in good faith, to bid upon the project.** The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

A pre-bid conference will not be held based on recommendations from the SD Department of Health and the COVID-19 situation. However, visiting the site is highly encouraged and the Engineer may be able to meet on-site by appointment if so requested by prospective Bidders.

Bid security shall be furnished in accordance with the Instructions to Bidders.
