Sealed Bids for the construction of the **Sisseton Concrete Drainage Channel Project, A-7298** will be received by **City of Sisseton**, at the **City Hall, 406 2<sup>nd</sup> Ave W, Sisseton, SD**, until **2:00 p.m.** local time on **October 3, 2019**, at which time the Bids received will be opened publically and read.

**Bids are invited upon the items and approximate quantities and summary of work as follows:**

## **Base Bid– 10’ Concrete Drainage Channel**

The Base bid work includes various items for the construction of a 10-foot wide 6” thick concrete channel, work includes the approximate list of quantities but is not limited to;

1,149 Cubic Yards of Unclassified Excavation, 900 Square Yards of Geotextile Separator Fabric, 875 Tons of Subbase Course, 4,950 Square Feet of 6” Concrete, 577 Cubic Yards of Topsoiling from Stockpiles, 1.0 acres of Seeding, Fertilizing and Mulching, 100 Feet of Erosion Control Wattle, 900 Square Yards of Type II Erosion Control Blanket along with additional miscellaneous items and incidental work.

## **Alternate Bid – 4’ Wide Concrete Valley Gutter**

Alternate Bid includes various items for the construction of a 4 foot wide 6” thick concrete valley gutter in lieu of the 10-foot wide channel, work includes the approximate list of quantities but not limited to the following items:

387 Cubic Yards of Unclassified Excavation, 186 Cubic Yards of Disposal of Excess Material, 100 Tons of Base Course, 1,980 Square Feet of 6” Concrete, 148 Cubic Yards of Topsoiling from Stockpiles, 0.25 Acres of Seeding, Fertilizing and Mulching, 100 feet of Erosion control waddle, 900 Square Yards of Type II Erosion Control Blanket along with additional miscellaneous items and incidental work.

Bids will be received for a one prime Contract. Bids shall be on a lump sum and unit price basis, with the Alternate bid items as indicated in the Bid Form.
