Sealed Bids for the construction of the **Terminal Parking Lot Improvements** will be received by the **City of Watertown**, at the office of the **Finance Officer, 23 2<sup>nd</sup> St. NE, P.O. Box 910, Watertown, South Dakota, 57201** until **10:00 a.m.** local time on **October 6, 2017**, at which time the Bids received will be **publicly** opened and read.

The Project consists of constructing the Watertown Regional Airport Terminal Parking Lot. Work includes: shaping and re-compacting the existing recycled asphalt material, Hot Mix Asphalt or Portland Cement Concrete paving, topsoiling, seeding, and other items of related construction.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Partial sets of the Bidding Documents will not be available from the Issuing Office.
