The following modifications are made to the plans and specifications for the Aberdeen Water Tower and Transmission Line Project.

CONTRACT DOCUMENTS AND TECHNICAL SPECIFICATIONS

1. Section 33 11 00 Water Utility Piping and Fittings; Part 1.04F (see addendum #1): add the following paragraph;

In lieu of LDPE caps and plugs for transport and storage, contractor may have the pipes wrapped sufficiently to limit intrusion of dirt and debris. Contractor shall use caps or plugs for staging and installation to limit intrusion of dirt, debris and water. Contractor shall have a minimum of 24 pipe able to be temporary capped and plugged.

SHEET 6: Asphalt Trench Repair Detail: Add the following Note: For 6" nominal asphalt pavement thickness the contractor shall install in three-2" compacted lifts.


- 1. On Drawing E5, delete Detail 5.
