- 3. <u>Contract Bonds</u>: Separate Payment and Performance Bonds guaranteeing faithful performance of the Contract and payment of all labor, materials, rentals, etc., will be required for an amount equal to one hundred percent (100%) of the amount of the Contract. All bonds must be issued or co-signed by a licensed resident agent of South Dakota.
- 4. <u>Commencement and Completion</u>: The Engineer will set the beginning date in a written "Notice to Proceed with Construction". The Contractor shall begin the work within ten (10) days of the date set forth in the written "Notice to Proceed" and shall complete the work within the number of calendar days, working days, or completion date or dates as shown in the Specifications.
- 5. <u>Title VI</u>: The <u>Rosebud Sioux Tribe</u>, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 USC §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders or offerors that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
- 6. <u>Minimum Wage Rates</u>: The successful bidder will be required to comply with all applicable Federal Labor Laws, including the minimum wage rates decision of the United States Department of Labor.
- 7. <u>Affirmative Action</u>: A Contractor who may be awarded a contract of \$10,000 or more and subcontractors who may be awarded a subcontract of \$10,000 or more will be required to maintain an affirmative action program, the standards for which are contained in the advertised specifications.
- 8. <u>Award of Contract</u>: The right is reserved, as the interest of the <u>Rosebud Sioux</u> <u>Tribe</u>, South Dakota, may require, to reject any and all bids, to waive informality in bids received, and to accept or reject any items of any bid, unless such bid is qualified by specific limitation.

- 9. The contractor will certify that he and any of his subcontractors meet the requirements of 49 CFR, Part 29, regarding debarment, suspension, ineligibility and voluntary exclusion as further described in these specifications.
- 10. The contractor will certify that he and his subcontractors will comply with the 49 CFR, 30.17, regarding Foreign Trade Restrictions as further noted in project specifications.
- 11. The contractor will certify that he and his subcontractors will comply with "BUY AMERICAN CERTIFICATION (JAN. 1991)" as further noted in project specifications.
- 12. The contractor shall submit an acceptable Tribal Employment and Contracting Rights Office (TECRO) compliance plan. The contractor/subcontractor shall not commence work until the compliance plan has been approve by the TECRO office, and a copy has been received by Helms and Associates.

The contractor will pay a TECRO fee of four and five-tenths percent (4.5%) of the total contract dollar amount.

Any contractor/subcontractor not submitting an acceptable compliance plan may be denied the right to commence or continue business on the Rosebud Sioux Tribe Reservation.
