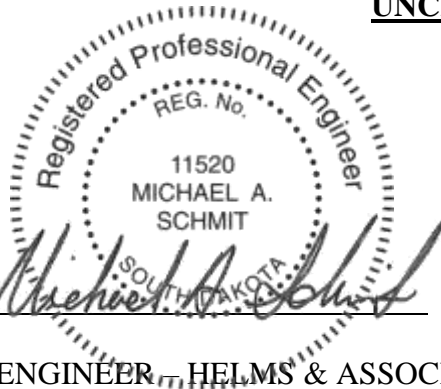
**Base Bid:**
